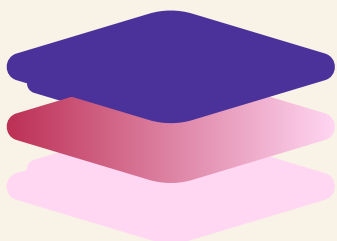
CENTRE FOR ALTERNATIVE DISPUTE RESOLUTION, NLIU

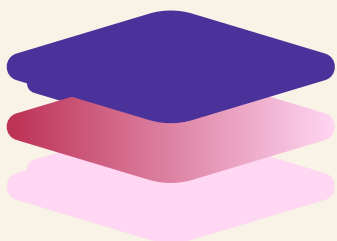
BHOPAL

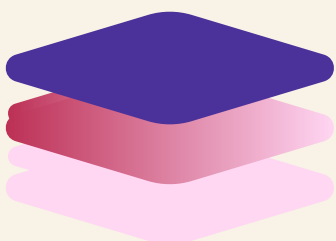

THE COMPETITION

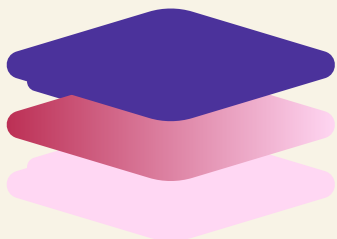


Since its inception in 2007, the vision of CADR has been to disseminate knowledge relating to Alternative Dispute Resolution Mechanisms and create a platform for like minded and zealous individuals to come together to revolutionize the process of dispute settlement.

This goal became a reality in 2012 with the Centre organizing Asia's oldest as well as India's largest Mediation Tournament, the "NLIU INADR International Law School Mediation Tournament". With each successive year, we have witnessed participation from all National Law Schools and premier private law schools of the country besides Universities in United States, Australia and parts of Europe.



The competition aims to provide an opportunity for students to be a part of disputes akin to actual altercations witnessed by legal professionals. It further presents an opportunity to hone the requisite communication and mediation skills in addition to holding discussions with equally enthusiastic professionals and students in the field. The nuanced feedback offered by our judges with years of experience allows the participants to assess and enhance their performance. The judges, who are highly revered professionals, also bring in diverse opinions owing to their international cohort.

DETAILS

I. FORMAT OF THE TOURNAMENT

The competition shall be in the format of a mediation competition wherein each team shall consist of 3 participants, i.e. the Client, the Counsel, and the Mediator. The number of teams has been limited to 40. The same would be selected on a first-come basis. The tournament shall have 3 Preliminary rounds and 3 Advanced Rounds (the Quarter-Finals, Semi- Final and the Final).

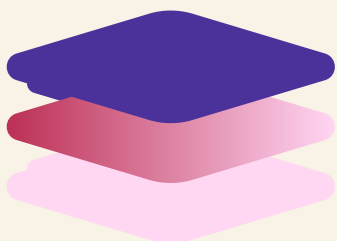
Further, it shall be mandatory for each member of the team to play the role of the client, counsel and mediator once. The time-limit shall be 60 minutes for the Preliminary Rounds, and 90 minutes for the Advanced Rounds.

II. REGISTRATION PROCESS

Teams may register themselves by filling up the Registration Form. Upon confirmation of their registration, the teams will be sent a payment link to make the payment of registration fees and an accompanying form to attach the proof of payment. Registration shall be deemed to be completed only upon the receipt of confirmation of payment from NLIU CADR.

III. REGISTRATION FEES

- INR 14000 per team- For Indian Teams.
- USD 150 per team- For Foreign Teams.



IV. COACH

Every team may be accompanied by one coach. The registration fee for the coach is INR 3000 for an Indian team and USD 30 for an international team. Accommodation for only the international coaches will be arranged by the Organising Committee.

The team coach is also permitted to attend their team's mediation sessions, however would not be allowed to assist the team during the Confidential Information release. The team coach shall also receive a certificate of recognition at the conclusion of the competition.

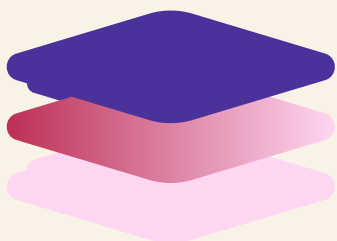

VI. TRAINING SESSION FOR JUDGES AND PARTICIPANTS

This competition will also provide an opportunity for the participants to develop the requisite negotiation and communication skills through various training sessions conducted by industry professionals from all around the globe. Basic training dealing with the functioning of the tournament shall also be incorporated for judges as well as participants.

VII. REACHING NLIU

The campus is situated at a distance of 15 kms from the Bhopal Railway Station and 13 kms from the Rani Kamlapati (Habibganj) Railway Station. The Bhopal International Airport is located 21.5 kms from the NLIU Campus. For international teams, the most convenient connecting flights can be accessed from Delhi or alternatively, Mumbai. We shall arrange for travel from these locations to the accommodation and the campus.

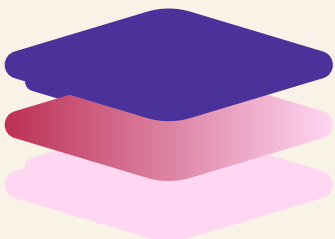

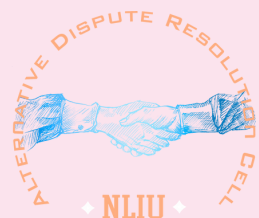

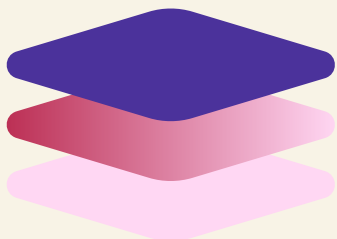
